

## Data protection notice for suppliers

11/24

### Dear suppliers,

The protection of your personal data is important to us. As part of our business relationship and depending on the specific purpose for which we collect your data, we also regularly process personal data if you are a legal person. This is the case, for example, when we collect data from members of your management or personal contact persons of your company, such as sales employees or other staff in departments that are relevant for our business relationship. According to the EU General Data Protection Regulation (GDPR), we are required to inform you about the purpose for which we, OGL Food Trade Lebensmittelvertrieb GmbH, collect, store or transfer your data.

### Processing purpose

We process your personal data as part of the business relationship:

- we collect your personal data as part of the business transaction, which also includes collecting the business contact of an employee.
- we only collect your personal data if the business contact can only be assigned to a natural person. This situation only applies due to tax law requirements.
- we collect your personal data as part of controlling access to our business premises for reasons of IT security.

Basically, we only process master data (surname, first name, business contact details, telephone number, etc.) for the purposes listed. We will inform you if extended master data are processed for a specific purpose.

### Legal basis

We process data on the legal basis of **Art. 6 (1)(b), (c) and (f)** of the **GDPR**. Our legitimate interest is commercial. We also have a legitimate interest in verification in the context of security (access).

### Recipients of the data

Your personal data will only be transferred internally to fulfil the stated purposes or to fulfil legal requirements. All responsible employees are required to protect the confidentiality of your data. Furthermore, only those employees will receive your data who need it to fulfil the purpose (need to know).

Your personal data may be transferred externally to the following types of recipients:

- Processors
- Public authorities that receive data due to legal regulations (tax authorities and health authorities).

Your data will also be transferred to the following businesses in our Group:

- OGL Digital Service GmbH
- Fruitservice GmbH
- Bellafrut s.a.s.

### Transfer to a third country

Furthermore, it cannot be ruled out that your personal data will be transferred to a third country. Before transferring your personal data, we will ensure that an appropriate level of data protection is in place, be it through an adequacy decision by the European Commission, guarantees or certifications, such as a standard EU contractual clause.

### Data retention

Lawmakers have enacted a number of retention periods, which we observe with the utmost care in order to comply with these obligations. In this context, we generally store your personal data only for as long as the stated purpose allows, or as required by law for reasons of proof. As part of the business relationship, we generally store your personal data for 10 years in accordance with commercial and tax law requirements.

### Your rights as data subject

You have the following rights:

- Right to access (Art. 15 GDPR)
- Right to rectification (Art. 16 GDPR)
- Right to erasure (Art. 17 GDPR)
- Right to restriction of processing (Art. 18 GDPR)
- Right to notification (Art. 19 GDPR)
- Right to data portability (Art. 20 GDPR)
- Right to object (Art. 21 GDPR)
- Right to withdraw consent (Art. 22 GDPR)
- Right to lodge a complaint (Art. 77 GDPR)

If you have given us consent to process your data, you can withdraw this at any time with effect for the future. Withdrawal will not affect the lawfulness of processing before the withdrawal. ### Information on lodging a complaint with a supervisory authority

If you consider that the processing of your personal data by OGL Food Trade Lebensmittelvertrieb GmbH infringes the GDPR, you have the right to lodge a complaint with a supervisory authority without prejudice to any other administrative or judicial remedy.
